Advocacy Impact

Working collaboratively, we have seen progress in the following areas:



\$546M over three years for new or expanded interprofessional care teams.



New legislation to eliminate sick notes for short-term illnesses.



Funding for a provincial Al scribe pilot program.



Insurance association statement discouraging referrals for paramedical services.



Clarified roles and responsibilities of family physicians and specialists to help ensure care-related activity happens in the right setting.

The OCFP will continue to work with government and partners to address practice pain points, while remaining focused on longer term goals of advocating for appropriate remuneration, identifying potential new models of primary care and ensuring every Ontarian has access to interprofessional team-based care, anchored by a family physician.

Mental Health, Substance Use Disorders and Chronic Pain

Two unique OCFP programs provide family physicians with an opportunity to connect and share, while meeting the growing needs of Ontarians related to mental health, substance use disorders and chronic pain.

Community of Practice

- Built by family physicians for family physicians, this monthly community of practice connects family physicians in real time to learn from others who are working with patients to address their mental health, substance use disorders and chronic pain, while also focusing on their own wellness.
- 1914 attendees over 12 sessions.

Peer Connect

 Participants receive support to skillfully respond to mental health issues, address substance use disorders and chronic pain challenges in practice, while also making space to prioritize and strengthen their own well-being.

Year in Review

New OCFP Initiatives

Family Doctors Enabling Integrated Care

New program to provide Mainpro+ certification support to integrated healthcare teams (i.e., OHTs).
 The OCFP helped certify seven sessions from five OHTs.

Equity, Diversity and Inclusion Focus Groups

- As part of our commitment to EDI, the OCFP started the process of deeper engagement to better understand the experiences of members through an anonymous survey and a series of focus groups of women and non-binary family physicians.
- The opportunity to better understand experiences related to bias, exclusion, discrimination and inequities across practice settings will inform the future state of work in education, supportive networks and leadership development.
- An action plan based on findings and recommendations will be developed in 2024-2025.
